8-1-1: ST. PAUL WATER UTILITY CODE ADOPTED:

The City hereby adopts the St. Paul Water Utility Water Code, dated February, 1995, by reference and incorporates into the City Code as though fully set forth herein the rules, regulations, policies and conditions of the St. Paul Board of Water Commissioners. (Ord. 90, 11-28-1995)

8-1-2: UNAUTHORIZED USE PROHIBITED:

No person shall take any water service from the City water system without proper authority therefor. (Ord. 26, 11-15-1974)

8-1-3: APPLICATION; IMPLIED CONSENT:

Every person applying for water service from the City system, and every owner of property for which application is made, shall be deemed by such application to consent to all rules, regulations and rates contained in this Chapter and all of the rules and regulations of the Board of Water Commissioners of the City of St. Paul, and all modifications thereof, and all new rules, regulations or rates hereafter duly adopted. (Ord. 26, 11-15-1974)

8-1-4: SERVICE CONNECTIONS:

A. All service connections shall be installed from the water main to the property line by the Board of Water Commissioners of the City of St. Paul, under rules in effect in the City of St. Paul.

B. No connection shall be made by a property owner to the water system of the City unless it is made in accordance with said rules and regulations of the City of St. Paul. (Ord. 26, 11-15-1974)

8-1-5: INSTALLATION OF METERS:

For the purpose of installing meters, duly authorized employees of the Board of Water Commissioners of the City of St. Paul are hereby authorized and may legally enter upon any premises in the City at any reasonable hour. (Ord. 26, 11-15-1974)

8-1-6: WATER RATES:

Water rates for water service provided within the City shall be established by the City Council, from time to time, by resolution. (Ord. 26, 11-15-1974)

8-1-7: DISCONTINUANCE OF SERVICE:

The City reserves the right to discontinue service of water without notice when the same is necessary in repair of the system or any part thereof, or for nonpayment of bills. (Ord. 26, 11-15-1974)

8-1-8: PENALTY:

Any person violating this Chapter shall, upon conviction therefor, be subject to penalty as provided in Section 1-4-1 of this Code. (Ord. 26, 11-15-1974; 1996 Code)
