Both the male and female were transported to the hospital for evaluation. The male was later identified as a 33 year old male with outstanding warrants for 3rd degree burglary, false information and fleeing police. This case was referred to the city attorney's office to charge the female with gross misdemeanor false information to police.</p> |

After being discharged for a foot injury, the suspect was booked at the Ramsey County Jail on the felony warrants and St. Anthony charges of misdemeanor fleeing an officer on foot and obstructing the legal process. The driver was arrested for gross misdemeanor operating an uninsured vehicle and driving after revocation. She was advised she would be charged via formal complaint for the violations.</p> |
