When the driver observed the squad car he immediately began to flee. Based on observations, the driver was recognized and positively identified by the officer, as a 32 year old male. Due to erratic driving and heavy traffic from the fair no pursuit was initiated. Investigation confirmed the identity of the driver. An alert was issued for the motorcycle. This case will be forwarded to investigations to charge the driver with felony flee police in a motor vehicle.

They advised that the child was currently safe and with her mother. Our case was referred to investigations for the charges of felony domestic assault by strangulation and two counts of misdemeanor domestic assault.
